TRAIL REGISTRY GUIDELINES The goal is to create a visual trail to promote heritage tourism with the display of unique quilt blocks connecting the beautiful buildings and landscapes throughout the Finger Lakes Region. The following criteria must be met to be listed with the FLXBQT:

1. The building is located on a public road accessible year round.
2. The building and Barn Quilt Block is visible from the road. The building and grounds are kept in good condition and are well maintained.
3. The Barn Quilt Block is made from aluminum composite sign board, MDO sign board, or solid wood. Quilt blocks that are 4'x4' and larger are listed in the Primary Trail. Quilt blocks smaller than 4'x4' are listed in the Secondary Trail.
4. The design expresses individual characteristics to provide a positive impact and does not include a company logo, words, or advertising.
5. The owners complete this Application-Agreement for registration with the Barn Quilt Trail.

FINGER LAKES BARN QUILT TRAIL (FLXBQT) AGREEMENT The undersigned accepts the requirements listed below to register and be included with the FLXBQT. Initial each line.

1. ___ I understand and agree to the Trail Registry Guidelines listed above. I further understand that the quilt block is my property and I am responsible for mounting it. FLXBQT volunteers may be able to assist with the installation for an additional fee.
2. ___ I recognize that mounting a quilt block on my building and registration with the FLXBQT may increase visitors and traffic to my location. I further grant permission for photographs of my property and quilt block be taken by the general public from the roadside. (Please know that we will convey in the FLXBQT trail directory, web site, and promotional materials that visitors are prohibited from trespassing onto private property.)
3. ___ I grant the FLXBQT volunteer group permission to list my address and photographs in any promotional, advertising, social media, web site, and fundraising materials..
4. ___ I understand that only business names will be published in the FLXBQT promotional mediums, as listed in the Property Owners section. I give permission to publish my personal name as provided. Name _____
5. ___ I agree that the quilt block will be hung on my building for a minimum of three years. I am responsible for any maintenance to the quilt block, building, and property. I will keep the quilt block unobstructed and visible from the road. In the event that I sell my property or remove the quilt block from its location, I will notify the FLXBQT volunteer group to allow them to remove my listing from all promotional endeavors.
6. ___ I understand that this Application-Agreement must be approved by the FLXBQT volunteer group before my quilt block is included with the FLXBQT trail registry.
7. ___ **I agree to hold harmless and indemnify the Finger Lakes Barn Quilt Trail volunteer group, as well as its agents, partners, and sponsors against any and all claims, liabilities, losses, and causes of action related to the FLXBQT including the mounting of a Barn Quilt Block on my property.**
